Re: E2023/35 Australian Municipal, Administrative, Clerical and Services Union - Post Election Report

I refer to the Post-Election Report dated 19 April 2024 issued by you as the Returning Officer ('RO') per section 197(1) of the *Fair Work (Registered Organisations) Act 2009* (the' FWROA').

On behalf of the ASU, per section 198 of the Act, I am responding to the report in relation to that election.

ASU Rules the AEC found ambiguous, and difficult to interpret or apply

By s197(2) you must report on <u>any rules of the organisation or branch which because of ambiguity or</u> <u>other reason, were difficult to interpret or apply as per Regulations 141(1) as follows:</u>

141 Post-election report by AEC (s 197 (2))

- (1) For subsection 197 (2) of the Act, the following matters are prescribed for inclusion in the report (the **post-election report**) given under subsection 197 (1) of the Act:
- (a) the declaration mentioned in regulation 140;
- (b) <u>any rules of the organisation or branch which because of ambiguity or other reason, were</u> <u>difficult to interpret or apply;</u>
- (c) any matters in relation to the roll of voters including those matters contained in subsection 197 (3) of the Act;
- (d) the number of written allegations (if any) of irregularities made to the AEC during the election;
- (e) action taken by the AEC in relation to those allegations;
- (f) any other irregularities identified by the AEC and action taken by the AEC in relation to those other irregularities.

(Emphasis added)

Your report records that the following ASU rules were 'ambiguous, and difficult to interpret or apply'.

a) <u>National Rules – PART VIIIA</u>

The ASU response to the two national ASU sub-rules 71 g & 76 b referred to in the report at page 9 is as follows:

Rule 71 PROCEDURE AT ELECTIONS

ASU Sub-rule 71 g. provides:

- g. The Branch Returning Officer conducting the respective election <u>must</u>:
 - *i.* provide a draft of the proposed ballot paper to the Branch Secretary to enable the Branch Secretary to consider the proposed ballot paper;
 - *ii.* consult with the respective Branch Secretary in relation to whether the ballot paper is compliant with the electoral rules prior to printing the ballot papers for the election; and
 - *iii.* have the Branch Secretary certify in writing that the draft ballot paper accords with the requirements of the ASU Rules.

(Emphasis added)

The ASU rejects the proposition that rule 71 is ambiguous, and difficult to interpret or apply.

That the AEC has policies and procedures respecting draft ballot papers is not relevant or germane, to the task that must be performed by the AEC – see ss 193 and 195 of the FWROA. Those policies do not provide a basis for determining 'ambiguity' nor 'difficulty in application'. The language of rule 71 is clear it requires a step to be taken.

The Act requires that the rules of the organisation (as certified by the FWC) must be followed pursuant to s193(1)(a) of the FWROA. Absent an irregularity the AEC must perform the action required by the rules. There is no circumstance of an irregularity. In R2022/100 the Fair Work Commission certified rule 71 after rigorous scrutiny of all aspects of the new electoral rules in ASU Rules PART VIIIA ([2022] FWCD 5 – 22 December 2022).

The AEC cannot depart from applying rule 71 absent an irregularity.

The ASU rejects any contention that a defined and transparent process of approving a draft gives rise, of itself, to an irregularity. We note that the AEC has not put this proposition to the ASU.

Further, and in any event, it is difficult to understand how it could be said by the AEC that the application of a general policy could defeat a specific rule as certified. Where does the AEC contend it derives such power from, other than the provisions of s 193 of the FWROA, dealt with below.

The ASU stands by its electoral rules requirements that have been certified by the FWC and are consistent with the FWROA and FWRO Regulations. The ASU puts the AEC on notice that it will in all future elections require compliance, by the AEC, with its certified rules absent action under section193(1)(b) of the FWROA.

Rule 76 ASSUMPTION AND TENURE OF OFFICE

ASU Sub-rule 76 (b) provides:

b. The Returning Officer conducting the respective election is to declare the candidates elected in that election:

- *i.* where the number of candidates for the offices to be elected in the election do not exceed the number of offices to be filled, as soon as is practicable but no later than <u>ten (10)</u> days after the close of nominations; or
- *ii.* where a ballot is required for all, or some, of the offices to be elected in the same election as soon as is practicable but no later than <u>ten (10) days</u>, after the close of the ballot.

(Emphasis added)

Regulation 140 provides a date for the declaration of candidates elected as soon as practicable but <u>no</u> <u>later</u> than 14 days after the close of nominations when unopposed or after the close of a contested ballot. To put this another way the regulation provides for a maximum time in which declaration may occur, <u>not a time in relation to which declaration cannot be made</u>.

The FWC had approved this timeline as being consistent with the FWROA and FWRO Regulations. The rule as presently cast is lawful.

It appears that the AEC misunderstands the law.

Setting the period at 10 days is consequently lawful, it is also not ambiguous nor is it difficult to interpret or apply.

However, the ASU, noting that this may cause some practical difficulty in relation to the period required to correct defects or to withdraw nomination, will vary this rule to refer to a period of 14 days.

b) Branch Rules – PART IX

<u>Qld Together Branch Rule 38</u>

Branch Rule 38 provides:

38 – PROPORTIONAL REPRESENTATION

- a. Notwithstanding any provisions of these Branch Rules, commencing in 2015 women will be represented on the Branch Executive and Branch Council as follows:
 - *i.* where the Branch has more than 50% women financial members, not less than 50% of the offices on Branch Council and Branch Executive will be filled by women; and
 - *ii.* where the Branch has more than 30% but less than 50% women financial members, not less than 30% of the offices on Branch Council and Branch Executive will be filled by women.
- b. At each Quadrennial Election, in addition to the requirements of PART VII of the National Rules, and any other requirements of these Branch Rules, the Branch Secretary will provide to the Returning Officer a certificate showing the percentage of women financial members at the close of nominations.
- c. In the event that, at the declaration of the election, the number of women elected to the Branch Executive does not equal or exceed the number required by the relevant provision of sub-rule a. of this rule, the Returning Officer will call for sufficient nominations from Branch Conference Delegates for the requisite number of Branch Executive Member (Women) to be filled by women as required by sub-rule a. is achieved.

a. Under this rule the office in column A is to be elected by, and from, the financial members attached to the electorate of the Branch set out opposite in column B or forming the Electoral College set out opposite in column C with the number of offices to be filled set out opposite in column D:

Rule 79 relevantly cross references the offices of 'Branch Executive Members (Women)' and 'Branch Council Delegates (Women)' to respectively rules 7 and 14 of the Together Branch Rules. Those rules are relevantly, and respectively, as follows:

7 – BRANCH EXECUTIVE

- a. The Branch Executive consists of the:
 - *i.* Branch President;
 - *ii.* Branch Senior Vice-President;
 - *iii.* three (3) Branch Industry Division Vice-Presidents;
 - iv. Branch Secretary;
 - v. two (2) Branch Assistant Secretaries;
 - vi. Branch Treasurer;
 - vii. Branch Assistant Treasurer;
 - viii. ten (10) Other Branch Executive Members; and
 - ix. Branch Executive Member (Women) (if any).
- b. The Branch Executive Officers will be elected at the Quadrennial Elections.
- c. i The number of members of the Branch Executive, provided for by sub-rule a. is subject to the Branch Returning Officer confirming, at the declaration of the Quadrennial Election for the Branch, that the provisions of rule 38 have been met.
 - *ii.* In the event that the provisions of rule 38 have not been met, then nominations will be promptly called in accordance with these Branch Rules for that number of the offices of Branch Executive Member (Women) as are required to be elected to achieve compliance with the provisions of rule 38.
 - *iii.* Those members elected to the office of Branch Executive Member (Women), subject to this rule will:

- A. hold office until the declaration of the next Quadrennial Election, they resign or they are removed from office in accordance with the National Rules or these Branch Rules; and
- *B. be entitled to exercise the same powers and have the same obligations as other members of the Branch Executive.*
- iv. This sub-rule does not prevent the elections for the other offices of the Branch Executive from being declared, and those officers declared elected take office, even though there is a requirement for an election for an office, or offices, of Branch Executive Member (Women).
- *d.* A member of the Branch Executive who ceases to be a member attached to the Branch immediately ceases to be a Branch Executive Officer.

14 – BRANCH COUNCIL

- a. The Branch Council consists of the persons elected to and holding, in accordance with these Branch Rules, the offices of:
 - *i.* Branch Executive Officer;
 - *ii.* 40 Branch Council Delegates elected by, and from, the Branch Conference; and
 - *iii.* Branch Council Delegate (Women) (if any).
- b. The Branch Council Delegates will be elected at the Quadrennial Elections.
- c. i. The number of members of the Branch Council, provided for by sub-rule a. is subject to the Branch Returning Officer confirming, at the declaration of the Quadrennial Election for the Branch, that the provisions of rule 38 have been met.
 - *ii.* In the event that the provisions of rule 38 have not been met, then nominations will be promptly called in accordance with these Branch Rules for that number of the offices of Branch Council Delegate (Women) as are required to be elected to achieve compliance with the provisions of rule 38.
 - *iii.* Only Branch Conference Delegates who are women may nominate for the office of Branch Council Delegate (Women).
 - *iv* Those members elected to the office of Branch Council Delegate (Women), subject to this sub- rule will:
 - A. hold office until the declaration of the next Quadrennial Election, they resign or they are removed from office in accordance with the National Rules or these Branch Rules; and
 - B. be entitled to exercise the same powers and have the same obligations as other members of the Branch Council.
 - v. This sub-rule does not prevent the elections for the other offices of the Branch Council from being declared, and those officers declared elected take office, even though there is a requirement for an election for an office of Branch Council Delegate (Women).
- *d.* A member of the Branch Council who ceases to be a member attached to the Branch immediately ceases to be a Branch Councillor.

These rules in turn refer to Together Branch Rule 38. That rule provides the requirement for the number of offices to be filled. It does not provide for a 'quota', rather it provides a formula for the ascertainment of how many offices (if any) need to be created and filled. It is a balancing proposition and only operates to 'top-up' when required i.e. if the number of women on Executive or Council is not sufficient to reflect the female membership of the Union.

The 'Proportional Representation' rule has been a feature of the ASU rules for a considerable period and over many election cycles (see Qld Services and Northern Administrative Branch Rule 34).

Given that the rule could be incorrectly interpreted by the AEC in future the ASU will seek to amend accordingly to ensure clarity and consistency.

Difficulties encountered by the ASU in the AEC administration of the Elections

a) ASU National issues

Election timetable & Preliminary Discussions

The FWC handed down a decision re Arrangement for Conduct of Election [2023] FWCD 1010 on 4 April 2023 a full month before Nominations opened yet the AEC did not appoint a Returning Officer until late April 2023. This was despite inquiries initially by phone and later in writing to the AEC on 21 April 2023 (see Appendix A) by the ASU. The ASU was eventually advised on 24 April 2023 that Ann Dougan had been appointed as the Returning Officer. A meeting between Ms Dougan and ASU National Secretary was organised for 26 April 2023 and drafts of election notices were sent on 24 April 2023 (see Appendix B).

At the meeting on 26 April there were a number of outstanding issues that required further discussion. A further meeting between the RO and the ASU National Secretary occurred on 1 May 2023 to resolve outstanding items not agreed to in particular a potential delay in the election timetable. The ASU insisted on proceeding with the ASU rule timelines and argued that the proposed delay of the election timing because of outstanding branch related rule changes was unreasonable given that the FWC had ensured all outstanding ASU rule alterations were approved in advance of the pivotal date of nominations opening on 3 May 2023.

While the ASU electoral timetable was resolved consistent with the rules there remained other outstanding issues in the RO's first Planning Letter for the election dated 2 May 2023 (see Appendix C). As a result of some agreed changes including: removal of the membership email addresses requirement (Column 'F'), references to (Membership) "Roll" in place of "List" and removal of a requirement to provide the Roll of Voters "electronically" to members, there was a second AEC Planning Letter issued on 3 May 2023 (see Appendix D)

However there remained a few significant unresolved issues. These included: Column 'N' – Incorrect last known address and Column 'O'- Workplace Addresses.

It is important to note that the ASU had indicated to the AEC that based on legal advice we were advising Branches not to provide details in Column "N" and "O" as it was inconsistent with the requirement to make a signed Declaration on the membership register as it was on the required earlier date.

The ASU had also expressed concerns with the AEC's request for a one Team Nomination form, rather than a more practical compilation of team nominations forms completed separately where necessary but otherwise submitted once on behalf of a Team.

It is clear that the AEC had a chronic shortage of staff and resources. The response of AEC's Director Operations Ms Kaye Bartlett indicated as much when referring to RO Ms Dougan interviewing new staff on 4 May 2023 (see Appendix E). The ASU acknowledges that AEC staff often did the best they could with what they had to meet all timelines. The ASU also acknowledges the efforts made by Ms Bartlett, AEC Industrial Elections Assistant Director, Mr Ben Murray and support staff to assist the RO to rectify constraints on resources and time.

All ASU National concerns were conveyed in correspondence to Mr Ben Murray on 5 May 2023 (see Appendix F) following advice from John Payne from Hall Payne Lawyers (HPL'). The legal advice was generally followed by the AEC except for "last known addresses" and "indication of workplace addresses for members who only have a workplace address" which remained outstanding as highlighted by a follow up letter from ASU to the AEC dated 15 May 2023 (see Appendix G).

b) Branch issues

i) Victorian & Tasmanian Authorities and Services Branch (Vic/Tas A&S)

- Election Notice Delays -In correspondence dated 5 May 2023 from Hall Payne Lawyers to the ASU National Secretary legal advice addressed the Branch concerns with delays on publishing election notices prior to Nominations Opening on 3 May 2023 as a result of AEC causes (see Appendix H). The conclusion was there was no breach of the ASU Rule 65 nor the Act and there was no irregularity that arose.
- **Team Nominations** The Vic/Tas A&S Branch sought legal advice in relation to concerns with the AEC drafting of team nomination forms (see Appendix I ASU letter to RO re HPL Advice dated 9 May 2023). The advice related to avoiding confusion about the form and requirements of team and individual nomination forms. This issue was ultimately resolved satisfactorily but caused unnecessary confusion for all ASU Branches. It is clear the matter could have been resolved well before the electoral timetable.

ii) NSW & ACT (Services), SA&NT & QSNA Branches

In person ballots for the purposes of Stage 2 Collegiate elections in New South Wales, South Australia and Northern Territory and QLD Services were initially denied because of Covid concerns. As a result of legal advice and correspondence sent to the AEC this decision was reversed for all three Branches effected **(see Appendix J** - letter from NSW & ACT (Services) Branch to the AEC dated 26 June 2023).

iii) VIC PS Branch

Ballot papers should be sent to arrive on the day the ballot opens. Ballots were not arriving for up to 2 weeks into a 4-week process in a significant number of cases.

In conclusion the prospect of a delayed election timetable and several other disagreements about the interpretation of the newly approved ASU rules and apparent conflict with AEC policies caused unnecessary confusion, uncertainty, stress and legal costs for ASU national and branch officials involved with the administration of the quadrennial elections.

The running of the ASU elections requires the AEC to work constructively with union officials who have the responsibility of taking steps required by the electoral process.

Planning should start well in advance of a union election, e.g. 3 - 6 months, with meetings between the RO and National Secretary finalising the process detail to avoid ongoing disputation in relation to rule interpretation and AEC policies that are at odds with the FWROA and Union rules.

The ASU stands by its conduct and the advice it received and communicated to the AEC.

Re: Australian Municipal, Administrative, Clerical and Services Union Scheduled Election E2023/35

I refer to the discussion between yourself and Mr Payne, who acts on behalf of the ASU, that occurred on May 3.

As Mr Payne undertook to do, I now respond to the two (2) matters that were discussed.

Inclusions in the Rolls

- 1. The AEC planning letter for E2023/35 issued at 1.38pm on 3 May 2023 contains directions in relation to the rolls to be prepared by the ASU Branches for the purposes of the election.
- 2. The directions are set out in annexure A attached to the letter and for, the purposes of this correspondence, relevantly contains items:
 - (a) 'N Incorrect last known address (If you have eligible members with a last known address thought to be incorrect, you should code those members as "Y" or "yes" in this field.)'
 - (b) 'O Workplace addresses (If you have eligible members with only a workplace address, you should code those members as "Y" of "Yes" in this field otherwise, leave the field blank.)'
- 3. Section 193 (1) FWROA provides:

193 Provisions applicable to elections conducted by AEC

- (1) If an electoral official is conducting an election, or taking a step in relation to an election, for an office or other position in an organisation, or branch of an organisation, the electoral official:
 - (a) subject to paragraph (b), must comply with the rules of the organisation or branch; and
 - (b) may, in spite of anything in the rules of the organisation or branch, take such action, and give such directions, as the electoral official considers necessary:
 - (i) to ensure that no irregularities occur in or in relation to the election; or
 - (ii) to remedy any procedural defects that appear to the electoral official to exist in the rules; or
 - (iii) to ensure the security of ballot papers and envelopes that are for use, or used, in the election.

(Emphasis added)

- 4. The principal obligation of the AEC electoral official (EO) is to conduct the election under the rules of the respective organisation.
- Consequently, the first step is to consider the ASU's rules and to then consider whether anything arises that may give rise to an irregularity and enliven the obligation under subsection 193 (1) (b).
- 6. FWROR section 131 (2) provides:,

131 Preparation and inspection of voter rolls (s 182)

[...]

- (2) The roll of voters for the election must:
 - (a) be prepared at the direction of an electoral official; and

(b) <u>set out opposite the name of each person on the roll the postal address of that person;</u> and

(c) be closed within the time specified in the rules of the organisation.

(Emphasis added)

7. Section 191 FWROA provides:

191 Organisation to provide returning officer with copy of register

- (1) A person (the returning officer) conducting an election under this Part for an office or other position in an organisation, or branch of an organisation, <u>may give a written request to an officer or</u> <u>employee of the organisation or branch to make available the register of members</u>, or part of the register, kept by the organisation under section 230, to the returning officer for the purposes of the ballot.
- (2) An officer or employee of the organisation or branch commits an offence if he or she fails to comply with a request under subsection (1).

Penalty: 30 penalty units.

- (3) Subsection (2) does not apply if the officer or employee complied with the request as promptly as he or she was capable.
 - *Note:* A defendant bears an evidential burden in relation to the matter mentioned in subsection (3).
- (4) An offence against subsection (2) is an offence of strict liability.
 - Note: For strict liability, see section 6.1 of the Criminal Code.
- (5) If the register, or the relevant part of the register, is kept in electronic form, the returning officer may require the register to be made available in that form.
- (6) A request under subsection (1) must specify the period within which the register must be made available. The period must not be less than 7 days after the request is given.

(emphasis added)

192 Declaration by secretary etc. of organisation

(1) If:

- (a) a returning officer makes a request under section 191 in relation to the organisation's register; and
- (b) the returning officer gives written notice of the request to the secretary or other prescribed officer of the organisation or branch concerned;

the secretary or other prescribed officer of <u>the organisation must make a declaration, in</u> <u>accordance with subsection (2)</u>, that the register has been maintained as required by <u>subsection</u> 230(2).

Civil penalty: 100 penalty units.

- (2) The declaration must be:
 - (a) signed by the person making it; and
 - (b) given to the returning officer, and lodged with the FWC, as soon as practicable but no later than the day before the first day of voting in the relevant election.
- (3) A person must not, in a declaration for the purposes of subsection (1), make a statement if the person knows, or is reckless as to whether, the statement is false or misleading.

Civil penalty: 100 penalty units.

(Emphasis added)

- 9. Consequently, the electoral official is entitled to request that:
 - (a) the register or part of the register be made available; and/or
 - (b) a roll containing the name and residential addresses of members who will participate in a respective election be prepared.
- 10. The present request is for the register.
- 11. ASU rule 28 relevantly provides for its register:

28 - REGISTER OF MEMBERS

A register of the names and, so far as disclosed, the residential or private postal addresses of members of each Branch of the Union [...]

12. ASU rule 29 mandates that a member must report in writing a, relevantly, change of residential address:

29 - CHANGE OF ADDRESS

Any member changing place of employment or residence or terminating employment <u>shall report</u> in writing the new place of employment or residence or termination to the Branch Secretary within fourteen days of effecting such change.

(emphasis added)

- 13. Further Branch Secretaries are obliged by ASU rule 30 to purge the register.
- 14. The effect of these rules is that a Branch Register is confined to residential and private addresses of members of the respective Branch, and that absent a notification of change (of address) provides for the addresses of members for the purposes of preparing a roll.

141 Rules of organisations

(1) The rules of an organisation:

[...]

(b) must provide for:

[...]

- (xii) the keeping of a register of the members, arranged, where there are branches of the organisation, according to branches;
- 16. section 230 FWROA provides:

230 Records to be kept and lodged by organisations

- (1) An organisation must keep the following records:
 - (a) <u>a register of its members, showing the name and postal address of each member</u> and showing whether the member became a member under an agreement entered into under rules made under subsection 151(1);
 - (b) a list of the offices in the organisation and each branch of the organisation;
 - (c) a list of the names, postal addresses and occupations of the persons holding the offices;
 - (d) such other records as are prescribed.

Civil penalty: 60 penalty units.

- (2) An organisation must:
 - (a) enter in the register of its members the name and postal address of each person who becomes a member, within 28 days after the person becomes a member;
 - (b) remove from that register the name and postal address of each person who ceases to be a member under section 171A, or under the rules of the organisation, within 28 days after the person ceases to be a member; and
 - (c) enter in that register any change in the particulars shown on the register, within 28 days after the matters necessitating the change become known to the organisation.
 - *Note:* An organisation may also be required to make alterations to the register of its members under other provisions of this Act (see, for example, sections 170 and 172).

Civil penalty: 60 penalty units.

(Emphasis added)

- 17. The ASU Register, inclusive of the Branch Registers, are arranged in conformity with section 230.
- 18. Further, and where applicable to a respective Branch, attributes are able to be provided as an implied requirement arising from the existence within that Branch of specialty electorates i.e. gender-based offices. This information, whilst <u>not</u> part of the register, is able to be provided by utilising a Branches information systems kept as part of the record¹ of each member.
- 19. Pursuant to the ASU's privacy policy, the *Privacy Act 1988* (Cth) and the Australian Privacy Principles, information collected by the ASU may only be disclosed for the purpose for which it was collected. Information may be disclosed for another purpose if an exception applies. Those exceptions are:
 - (a) the individual has consented;

- (b) the individual would reasonably expect the information disclosed for a purpose that is related to the primary purpose;
- (c) the law requires;
- (d) 'permitted general situations' which include things like threat to life, health or safety and taking appropriate action in relation to serious misconduct.
- 20. The members have not consented. Further, besides the difficulty in identifying for what purpose incorrect personal information (such as that requested in N) could be collected, we do not believe our members would reasonably expect the information requested at N and O to be disclosed in these circumstances. This is because it is not required for the conduct of Union elections, nor is it required under any statute that the AEC has been able to identify. The request also does not fall under one of the permitted general situations.
- 21. The ASU is required by the FWROA to perform its rules see for example section 164 FWROA in relation to members rights.
- 22. For the reason set out above the ASU as a union (inclusive of its Branches) does not, and cannot, adjust its membership on the basis of return mail. It does not maintain such information as part of its formal records and it is not a component of the Membership Register. Further, and so there can be no doubt, no reliance could be placed on such information in any event as a reason for return cannot be interrogated see also ASU rule 71 m. and n..
- 23. In relation to the request for work addresses that is not part of the register and cannot be produced for the reasons set out above, particularly those relating to privacy concerns.
- 24. Section 192 FWROA provides:

192 Declaration by secretary etc. of organisation

- (1) If:
 - (a) a returning officer makes a request under section 191 in relation to the organisation's register; and
 - (b) the returning officer gives written notice of the request to the secretary or other prescribed officer of the organisation or branch concerned;

the secretary or other prescribed officer of the organisation must make a declaration, in accordance with subsection (2), that the register has been maintained as required by subsection 230(2).

Civil penalty: 100 penalty units.

- (2) The declaration must be:
 - (a) signed by the person making it; and
 - (b) given to the returning officer, and lodged with the FWC, as soon as practicable but no later than the day before the first day of voting in the relevant election.
- (3) A person must not, in a declaration for the purposes of subsection (1), make a statement if the person knows, or is reckless as to whether, the statement is false or misleading.

Civil penalty: 100 penalty units.

- 25. Such declarations must accord with the requirements of section 230 FWROA (see above) see also ASU rule 71 f. and 71 o..
- 26. In the circumstances the ASU (inclusive of its Branches) cannot comply with the request set out in items N and O see also ASU rule 71 e..

- 27. The ASU accepts that the AEC is obliged to avoid irregularity. It will consider a request made by the EO for the provision of information that is designed to deal with the prevention of an irregularity, albeit the Union would greatly appreciate the nature of that potential irregularity, that is required to be prevented, being identified see ASU rule 71 d.. If there is an appropriate basis that would of course go to the issue of satisfying privacy concerns relating to supply.²
- 28. The ASU requests that the AEC confirm in writing that there is no requirement to provide the information in N or O.

Team Nominations

- 29. As you are aware the ASU rules provide for Team Nominations.
- 30. Rule 68 relevantly provides:

68 - TEAM NOMINATIONS

[...]

- h. A Team Nomination must only nominate:
 - *i.* an Eligible Member, entitled when nominated to hold the office, for an office to be held by a single member; and
 - *ii.* the required number of Eligible Members, entitled when nominated to hold the office, where an office is to be held by multiple members,

for each office for which nominations have been called in the election, following which each Eligible Member concerned has nominated for the respective office concerned.

- *i.* A Team Nomination must be:
 - i. in writing; and
 - *ii.* signed by each candidate.
 - [...]
- 31. As the AEC is aware this will result in a document of significant size.
- 32. It is not practical, given the geography of the Branches with a number of the Branches extending beyond the borders of a single State, for 'one' document to be completed and executed by each candidate.
- 33. The practice in the past, which is accommodated by the language of the rules, is for multiple documents to be completed to form the Team Nomination and then lodged together as a compilation with the AEC.
- 34. We acknowledge that you have advised Mr Payne that such a course is satisfactory. In doing so you made clear, however, that the nomination (as a compilation) must be lodged at one time and you referred to 'as one email'.
- 35. Firstly, the ASU appreciates that acknowledgement, but secondly notes the following two (2) practical matters:
 - (a) on the team nomination form 'Note 2' states:

'in order to be able to be received by the AEC, email (including attachments) should be no greater than <u>6MB in size</u>'; and

(b) the ASU has been advised that the 'portal' cannot, for technical reasons, be utilised for team nominations.

- 36. The obvious concern of the ASU is if a compiled team nomination exceeds 6MB, how is it to be filed?
- 37. Consequently, I would appreciate your urgent advice as to the AEC solution to this issue given this is a technical issue entirely under the control of the AEC.
- 38. Further some candidates, particularly those without access to scanning equipment, will be signing their nominations by electronic means i.e., by applying an electronic facsimile of their signature.
- 39. I would request your advice by return, if you require further submissions in relation to this issue, as it is the view of the ASU that that conduct conforms with the rules, particularly noting that nominations can be lodged electronically and there can be no actual assessment of 'wet' signatures.

Please do not hesitate to contact either myself (0448 203 392), Mr John Nucifora (0419 595 417) or Mr Payne (0411 698 398) in relation to these matters should you have any issues that need to be resolved.

In that regard I am directed by the National Executive to make clear that the ASU is committed to the democratic electoral processes and will provide every assistance to assure that process.

Re: Australian Municipal, Administrative, Clerical and Services Union scheduled election E2023/35

I refer to your letter of 10 May in response to mine of 5 May 2023.

I note that you maintain that you can request incorrect last known address (Item N) and indication of workplace addresses for members who only have a workplace address (Item O). As I pointed out in my letter to you of 5 May your powers are limited to those provided in the *Fair Work Register Organisations Act*.

The FWRO Regulations provide that the roll of voters must contain the name of each person on the role and the postal address of that person. Section 191 of the FWRO Act provides that you may give a written request to an officer or employee of an organisation to make available a register of members or part of a register.

Under s.191(2) it is an offence to fail to comply with that request.

As I pointed out in my letter of 5 May you can only require production of the register or part of the register and/or a roll containing the name and residential address of members. You have stated in your letter of 10 May that the AEC is required to include certain matters in its post-election report. Items N and O in your request are directed at the post-election report. However nowhere in the FWRO Act is the AEC empowered to require the production of such information under pain of a criminal penalty.

I referred in my letter of 5 May 2023 to s.193 and the ability of the returning officer to give directions to ensure that no irregularities occur or to remedy any procedural defects etc. I note that you do not seek to rely on that section in respect of the request for the items in Items N and O, nor is it readily apparent how such reliance could be placed in any event.

Section 197 really only operates after an election has been completed. Under it the report must be prepared, and the AEC must include in the report the matters set out in ss.(3) if it forms that view. Section 197 has no work to do at this stage of an election in any event.

Insofar as the question of privacy is concerned, I do not accept your analysis. The information you seek under items N and O is not directed at the conduct of the election.

Re: Quadrennial Election 2023

We refer to the above matter and to the correspondence you have received from the Vic-Tas Branch Secretary, where Ms Darmanin raises the following issue:

'... I am concerned that just because the AEC is the cause of the delay or even that they say it is ok to put it on our branch websites or email later than 3 <u>May does not mean that the failure to do so could</u> <u>not be the subject of review down the track</u>.

I would like to get advice to give me comfort that there is not any risk that:

- the aec only publishing the election materials very late in the day

- my branch not having published the election material on our website at all yesterday

- my branch not having emailed members with a link to the material yesterday

<u>could be argued to be a defect or irregularity</u> in the election giving rise to any review/inquiry down the track.

We advise:

1. Rule 65 a. provides that the Branch quadrennial elections are to commence on 3 May:

Nominations for Branch Offices, of a respective Branch, open on the first Wednesday in May in the year of a Quadrennial Election.

2. Rule 65 b. provides:

A notice, calling for nominations in the Quadrennial Election for a Branch, is to be placed:

- *i.* on the ASU Website;
- *ii.* on the respective Branch Website;
- iii. in an ASU journal (if any);
- iv. in a respective Branch journal (if any); and
- v. in a respective Branch newsletter/communication.
- 3. We are instructed that the notices required to be published on the respective Branch Website (severably the **Notices**) (see rule 65 h.) were not provided in a timely way by the AEC Electoral



Official (EO) and were received by the ASU after the close of business of the Branches on 3 May.

- 4. Despite the late receipt of the Notices the Notices were relevantly posted to the ASU National Website, albeit late in the evening.
- 5. The following questions arise:
 - (a) what is the effect of rule 65 a.;
 - (b) has a breach of rule 65 a. occurred;
 - (c) has a breach of rule 65 occurred;
 - (d) has a breach of another rule or the FWROA occurred; and
 - (e) has an irregularity arisen.
- 6. We acknowledge that as a matter of preference the ASU would publish the election notices required by rule 65 on, or before, 3 May.
- 7. Rule 65 a. does not, however, mandate that the notice <u>must</u> be placed on the date that nominations open or on any 'particular' date. That is a 'date' that can be calculated in some way as a particular ascertainable time.
- 8. Rule 65 does not 'tie' the requirement to provide notice (see 65 b.) to rule 65 a..
- 9. If rule 65 is read as a whole, it can be seen that the ASU has expressly linked a number of subrules in rules 65 e.g. sub rule f. is linked to sub rule e..
- 10. If the ASU had intended to require the notice to be provided at a particular time referable to sub-rule a., it would have done so by making that proposition express e.g:

'... A notice, calling for nominations in the Quadrennial Election for a Branch, is to be placed <u>on the day</u> <u>of the opening of nominations under sub-rule a</u>. '

it did not do so.

11. Section 143(1)(b) FWROA provides:

143 Rules to provide for elections for offices

The rules of an organisation:
 [...]

(b) must provide for the conduct of every such election (including the acceptance or rejection of nominations) by a returning officer who is not the holder of any office in, or an employee of, the organisation or a branch, section or division of the organisation; [...]

- 12. It is not a requirement of the FWROA nor the FWROR for the rules of an organisation to stipulate the date on which notice of the opening of nominations must be given.
- 13. This proposition should also be seen in the context of the rules. The rules themselves set the time for the opening of nominations that is the primary notice to be given is the notice given by the rules themselves. Members are, as part of the membership compact, taken to be aware of the rules, particularly those who wish to participate in an electoral process.
- 14. Rule 65 does not provide a time for the provision of the Notices. The consequence of this, is that there is no particular time that the Notice is to be placed on a respective Branch website.
- 15. Rule 65 g. requires the EO to cause the branch notice to be placed. A respective Branch will only be able to place the notice if the EO provides the notice and makes the request.

- 16. Any delay that has occurred has not occurred as a consequence of the conduct of the ASU or any of its branches. It is directly a result of the conduct of the EO. However as Ms Darmanin properly asserts, that may not be to the point in reviewing the conduct of the election and considering whether an irregularity has arisen.
- 17. The obligation of the Branches is, following receipt of a notice from the EO (for a respective Branch) with a request to provide notice by the means under rule 65 b., the Branch should deal with that request in a timely way and in doing so its conduct will be compliant.
- 18. We understand our instructions are that that has occurred, albeit there has been some issue with accuracy of the Notices.
- 19. There is significant law in relation to 'irregularity' which is dealt with in part three of chapter 7 of the FWROA see particularly section 200 FWROA:

200 Application for inquiry

When member of organisation may apply for inquiry

(1) If a person who is, or within the preceding period of 12 months has been, a member of an organisation claims that there has been an irregularity in relation to an election for an office in the organisation or a branch of the organisation, the person may make an application for an inquiry by the Federal Court into the matter.

Note: For the meaning of *irregularity*, see section 6.

When Electoral Commissioner must apply for an inquiry

(2) If the Electoral Commissioner believes that the result of an election for an office has been affected by an irregularity in relation to the election, the Electoral Commissioner must make an application for an inquiry by the Federal Court into the matter.

When Electoral Commissioner may apply for an inquiry

(3) If the Electoral Commissioner believes that there has been an irregularity in relation to an election for an office, the Electoral Commissioner may make an application for an inquiry by the Federal Court into the matter.

Note: This section relates only to elections for office. It does not apply to elections for positions other than offices (which can also be conducted under Part 2).

20. The definition of the regularity is in section 6:

irregularity, in relation to an election or ballot, includes:

- (a) a breach of the rules of an organisation or branch of an organisation; and
- (b) an act or omission by means of which:

(i) the full and free recording of votes by all persons entitled to record votes and by no other persons; or

(ii) a correct ascertainment or declaration of the results of the voting;

is, or is attempted to be, prevented or hindered; and

(c) a contravention of section 190.

- 21. We do not consider, in so far as paragraphs (a) and (c) are concerned, that:
 - (a) there is a breach of rule; nor
 - (b) section 190.

- 22. In so far as paragraph (b) is concerned, the short period of time, in relation to the notice being placed following the commencement of the opening of nominations will not, in the circumstances where there is no mandated requirement for the notice to be published at a particular time and where publication did in fact occur by one of the means required, give rise to a circumstance under sub rule (b).
- 23. In Re Federated Liquor and Allied Industries Employees' Union of Australia; Ex parte Huxtable (1979) 40 FLR 418, (which has since been cited with approval by Flick J in Application of the Electoral Commissioner (2014) 226 FCR 144) Northrop J considered the meaning of the word irregularity in the context of organisational elections and stated:

'This provision does not give a definitive meaning to the word 'irregular' but extends the meaning, if necessary, to include specific matters.'

24. His Honour Mr Justice Flick in Application of the Electoral Commissioner (2014) 226 FCR 144) held the definition of 'irregularity' in the FWROA is not exhaustive and set out the decision of Northrop J:

"**151 The issue remaining to be decided on the preliminary issue is whether the facts assumed for the purposes of submission are capable of constituting an irregularity within the meaning of that word when used in s 165 of the Act. The word 'irregularity' is defined in the Shorter Oxford Dictionary (23rd ed. 1972 reprint) as 'the quality or state of being irregular; something that is irregular'. In the same dictionary, the word 'irregular' is defined in telation to things as 'not in conformity with rule or principle, contrary to rule; disorderly in action or conduct, anomalous, abnormal'. In the Act, by s 4, except where otherwise clearly intended, the word 'irregularity' has the following meaning: "Irregularity", in relation to an election or ballot, includes a breach of the rules of an organization or of a branch of an organization, and any act, omission or other means whereby the full and free recording of votes by all persons entitled to record votes, and by no other persons, or a correct ascertainment or declaration of the results of the voting is, or is attempted to be, prevented or hindered.'

- 25. The conduct must be further considered and whether it amounts, outside the definition in the Act to an irregularity.
- 26. Examples of where an inquiry has considered conduct are:
 - (a) producing misleading advertisements (Re Amalgamated Metals Foundry and Shipwrights Union; Ex parte Adamson (1984) 4 FCR 319);
 - (b) members nominated for office are unfinancial members (Re Killesteyn; Re Australian Medical Officers' Federation, Queensland Branch (2009) 193 IR 200);
 - (c) nomination received after the correct closing date for nominations, but before the date members had been erroneously notified of (Application of the Electoral Commissioner (2014) 226 FCR 144);
 - (d) nominations accepted by the returning officer despite non-adherence to the rules (Electoral Commissioner, in the matter of an inquiry relating to elections for officers in the Australian Federal Police Association Branch of the Police Federation of Australia [2016] FCA 469);
 - (e) failure to declare as elected the only candidate nominated (Electoral Commissioner, in the matter of an inquiry relating to elections for officers in the Australian Federal Police Association Branch of the Police Federation of Australia [2016] FCA 469);
 - a ballot did not open or close in accordance with the correct date (Electoral Commissioner, in the matter of an inquiry relating to elections for officers in the Australian Federal Police Association Branch of the Police Federation of Australia [2016] FCA 469);

- (g) the returning officer did not forward ballots in accordance with the rules (Electoral Commissioner, in the matter of an inquiry relating to elections for officers in the Australian Federal Police Association Branch of the Police Federation of Australia [2016] FCA 469).
- 27. The character of the 'transaction' presently being considered is very distinct and different from the character of the conduct that has been determined to amount to an irregularity.
- 28. In our view no irregularity arises. Further, there is no express requirement at law for notice of a particular length or to be given at a particular time, notice has been given at the opening of nominations by the ASU website and by the rules, the Branches have provided the Notices as soon as they were practicably able in conformity with the request of the EO and nothing remains to be perfected.
- 29. In answer to the questions posed above:
 - (a) rule 65 a. does not have the effect of requiring a notice to be given on the day that nominations open
 - (b) no breach of rule 65 a. has occurred;
 - (c) no breach of rule 65 has occurred;
 - (d) no breach of another rule or the FWROA has occurred; and
 - (e) no irregularity has arisen.
- 30. In our view there is no defect for the AEC to rectify, other than to the extent that has already occurred by perfecting the Notices.
- 31. In relation to the other issues raised by Ms Darmanin, we understand that:
 - (a) further communication is occurring between the ASU and the EO in relation to 'compiled' Team nominations, albeit that discussion has not dealt with the issue raised – the use of a non-team nomination form;
 - (b) our provisional view is that it should not matter as long as the compilation complies with the requirement of rule 68 i. that is form must not overcome substance;
 - (c) we will consider this matter and provide further advice, which we will do as sonn as we practicably can, noting the urgency;
 - (d) the issue of the e-signature (which we consider permissible) has been raised directly with the EO (Mr Potter's correspondence of even date) and we are waiting on a response.

We are available to discuss these issues further.

Re: Team Nominations

We enclose:

• Draft Individual Team Nomination

We refer to the above matter and to your request for advice to clarify certain issues that have arisen because of the electoral officer's (**EO**) approach to the drafting of the team nomination form for the ASU.

We confirm your instructions are that the advice we provide will be made available to all members of the Branch who make enquiry on this issue and that you propose to request that the ASU national office publish the advice, or a relevant extract of the advice, on the national website.

We advise:

- The FWROA and its regulations are silent on the 'form' of nomination see section 143(1)(d) FWROA.
- 2. The ASU rules are silent on the 'form' of nomination
- 3. Rule 67 provides for the nomination of candidates who are nominating individually. Rule 68 provides for the nomination of candidates who are nominating as part of a team.
- 4. The process of nomination is different from individual nomination to team nomination:
 - (a) an individual candidate must be nominated by relevantly qualified nominators see rule 67(b)– (d);
 - (b) a team candidate does not require to be nominated;
 - (c) an individual candidate <u>must consent in writing</u> to their nomination see rule 67(f); and
 - (d) a team candidate must sign the 'Team Nomination'.
- 5. The rules define 'Team Nomination', for the <u>purposes of the electoral rules</u>, as:

- ' ... a nomination of a group of Eligible Members under rule 68¹
- 6. Rule 68 is an electoral rule.
- 7. This definition is entirely consistent with rule 68 a.:

Subject to this rule, a group of Eligible Members may, in relation to an election for Branch Offices in their respective Branch, together nominate as a team for that election.

- 8. Rule 68 makes further provision:
 - (a) must only nominate an eligible member for an office when the member is entitled to hold that office;
 - (b) ensure there are sufficient team candidates for each office the subject of the election; and
 - (c) if nominating as a team candidate an eligible member may not nominate as an individual candidate.
- 9. In summary:
 - (a) a team candidate does not need to be nominated;
 - (b) a team candidate nominates by nominating as a member of a team with a group of other candidates;
 - (c) an eligible member must only nominate for an office when the member is entitled to hold that office;
 - (d) a team nomination is only valid if an eligible member is nominated for each office (inclusive of multi-member offices) in the election;
 - (e) the team candidate has signed the nomination; and
 - (f) the FWROA/rules do not provide for the form of a team nomination.
- 10. The powers of the EO are confined by section 193(1) FWROA to perform the rules, but an EO may give such direction as necessary to avoid irregularity.
- 11. It appears that the AEC (by its Assistant Director Organisations) has conceded that multiple documents can be utilised for the purposes of a team nomination. That is the form drafted by the EO does not have to be adopted as a single form with that single form signed by each team candidate. As we understand it formal confirmation has been sought but is still to occur.
- 12. The practice adopted by the EO has, however, differed from the approach adopted in at least the last quadrennial election. In that election the team nomination form utilised did not discretely set out each of the offices but rather provided blank boxes to be completed by each individual team candidate, in so far as the 'office' for which they were seeking to be a candidate was concerned.
- 13. The two nomination forms (team nomination/individual nomination) are inherently different for this reason.
- 14. The team nomination form is detailed as to office and then designed to have the relevant information completed.
- 15. The individual candidate form is essentially blank.

¹ See rule 58.

- 16. The forms are a creation of the EO. They have no relevance beyond the information they communicate. To put this another way the EO can only require compliance with the rules and cannot add a requirement that only a particular form be used².
- 17. Consequently, it is necessary to focus precisely on what is required for a team nomination. The team nomination requires a signature only, <u>but that signature must evidence</u> the eligible member concerned is nominating as part of a team.
- 18. Our concern is a practical one; the use of the individual candidate nomination form does not evidence a team nomination and arguably has the opposite effect. We consequently recommend against the use of the individual candidate nomination form by a candidate for team nominations.
- 19. In our view, however, there is no requirement for the EO's form to be used. A team in the Branch election could create its own individual nomination forms which, when compiled together, become the team nomination.
- 20. The essential elements of a team nomination form are set out above and there is no reason why those components cannot be created to relate to only one office. Each individual form would need to be signed by the respective candidate and those individual forms would then need to be compiled to form the team nomination.
- 21. To put the matter beyond doubt as to its compliance with rule 68 a. it is appropriate to title the form 'Team Nomination'. Further it would also be appropriate to indicate the name of the team in the headings, if that information was available at the time of creation of the form.
- 22. Further whilst it is our preference that the individual candidate nomination forms are not used, if as a last resort they are used, then the provision for nominations should be crossed out and the heading 'team' (preferably with the name of the team) added at the top of the form.
- 23. It would be appropriate if either the Branch or the national office raised this issue with the EO to confirm the process and following confirmation that advice be made available on the ASU's website.
- 24. To assist we have attached a draft form for team candidates to complete and sign.
