3.1 Artificial Intelligence - Queensland (Services and Northern Administrative) Branch

The following motion was referred to National Conference by the Queensland (Services and Northern Administrative) Branch to adopt the following motion into union policy.

Recommendation:

"The ASU supports a human-centered approach to artificial intelligence. We believe that technology should enhance our abilities, not replace human judgment or decision-making.

We believe in a participative and democratic approach to AI in the workplace, ensuring that its use and impact are clear and understandable for all workers. The foundations of AI, including how data is sourced and used, should be open and transparent.

The ASU supports the rights of every worker to:

- Work free of surveillance.
- Engage in work that promotes social and psychological wellbeing.
- Actively participate in decision-making processes regarding changes in the workplace.

In line with these values, we commit to:

- Advocating for AI technologies that align with legal and ethical standards.
- Supporting ongoing training and resources for workers to understand and engage with AI
 effectively.
- Promoting data privacy and security measures that protect sensitive information.
- Encouraging regular assessments of Al's impact on work processes, ensuring transparency in findings.
- Ensuring consultation with workers regarding any AI implementations that involve data collection or surveillance.
- Fostering collaboration and feedback mechanisms between employees and management regarding AI technologies.
- Upholding the principle that AI should not be used to eliminate roles without opportunities for re-skilling.
- Considering the environmental implications of AI technologies in organisational practices.

The ASU is dedicated to ensuring that AI technology enhances the work experience for all members while upholding their rights and dignity in the workplace."

3.2 Building Climate Safe Communities – South Australian & Northern Territory Branch and NSW & ACT (Services) Branch

The following motion was referred to National Conference by the South Australian & Northern Territory Branch and NSW & ACT (Services) Branch to adopt the following motion into union policy.

Recommendation:

"ASU members across our diverse sectors are on the frontlines of the climate crisis. Worker insights and experiences are crucial in shaping effective responses to the challenges posed by climate change and natural disasters.

As we confront the changing climate, we will ensure that workers are at the forefront of conversations about how these issues impact their lives and livelihoods. To achieve this, we will unite our efforts under a comprehensive plan that recognises the vital role of union members in advocating for climate justice, a just transition, and building climate-safe communities.

ASU National Conference commits to:

Championing a Just Transition

We will advocate for a just transition to renewable energy, ensuring that the Net Zero Economy Authority and Federal and State Governments actively listen to workers and communities.

This transition is essential for meeting our climate commitments, delivering quality jobs for our members, and providing cost-effective services.

Providing Essential Support for Workers

We will campaign and bargain in our workplaces for industrial entitlements and resources for workers experiencing the impacts of climate change. The ASU will:

- Develop resources to support ASU members focused on occupational health and safety, as well
 as addressing climate-related trauma and psychosocial safety, equipping members with the
 knowledge they need to navigate climate change and disaster impacts.
- Campaign for paid leave for emergency service volunteering and for those affected by climaterelated events, including salary maintenance for workers unable to work due to extreme weather conditions.
- Develop and campaign for industrial entitlements for workers supporting vulnerable people in communities experiencing climate-related crises and natural disasters.
- Campaign for adequate funding of services to support communities in adaptation, climate crisis, recovery and resilience.

Engaging Workers in Climate Justice

We will mobilise ASU members to participate in climate advocacy efforts, ensuring their voices are heard in discussions about the future of work in a changing climate. This issue matters deeply to ASU members, and we must empower workers to advocate for action in their workplaces and communities.

Protecting Our Energy Future

Supporting a just transition to renewable energy, as it is the most effective way to meet our climate commitments, deliver quality jobs for our members, and provide cost-effective essential services. This transition not only safeguards the environment but also ensures that workers are at the forefront of shaping a sustainable future. We will actively engage with all levels of government to protect our energy future.

By taking these steps, we will create a strong and united movement that can address the immediate impacts of climate change but build climate safe communities for ASU members."

3.3 Reproductive Health Leave – Queensland Together Branch

The following motion was referred to National Conference by the Queensland Together Branch to adopt the following motion into union policy.

Recommendation:

"This ASU affirms our ongoing commitment to the "It's for Everybody" campaign, which advocates for essential paid reproductive health leave for all workers. Reproductive health can impact all workers; it affects everybody at every stage of their working life, including, but not limited to, menstruation, fertility issues, breast and prostate screenings, and perimenopause and menopause.

Reproductive Health Leave is crucial for addressing the diverse needs of workers. Conditions related to reproductive health can not only cause significant physical discomfort but also contribute to mental health issues such as anxiety and depression. This impact on quality of life and productivity can lead to lost income or job loss.

Paid reproductive health leave would enable access to critical medical appointments and treatments, allowing workers to manage their health without the stress of financial insecurity. While Reproductive Health Leave is for everybody, it will also make a positive impact on women's leave balances in particular.

The ASU commits to:

- Developing comprehensive resources to assist members on having conversations about the importance of Reproductive Health Leave and its impact on worker health and wellbeing.
- Supporting the implementation of Reproductive Health Leave in workplaces by developing a model clause for workplaces.
- Advocating for a universal Reproductive Health Leave entitlement for all workers.

National Conference acknowledged a one-minute silence in memory of Cassius Turvey.

3.1 The Uluru Statement from the Heart – Voice, Treaty, Truth – Western Australian Branch

The following motion was referred to National Conference by the Western Australian Branch to adopt the following motion into union policy.

Resolution:

"Makarrata- Coming together after a struggle

The ASU recognises the prodigious history leading to the dialogues of Aboriginal and Torres Strait Islander peoples coming together and signing the Uluru Statement from the Heart, in 2017. This resolution of ASU National Conference 2022 is tied to the Uluru Statement.

The Uluru Statement from the Heart - Voice, Treaty, Truth

Aboriginal and Torres Strait Islander peoples seek recognition in the Australian constitution. Such constitutional reform must be more than symbolic.

Recognition should also enshrine substantive, structural reforms that are endorsed by Aboriginal and Torres Strait Islander communities. The principal reforms presented in the Uluru Statement, are the recognition of Aboriginal and Torres Strait Islander peoples as the First Nations of this land ('the Truth'), a Treaty linked to that sovereignty and a protected Voice to the Australian Parliament.

47th Parliament of Australia

The Albanese government, led by Prime Minister Anthony Albanese of the Australian Labor Party, made holding a referendum on an Indigenous voice to parliament during his first term, an election promise in 2022.

National Conference, therefore, commits to supporting First Nations peoples and the constitutional reforms presented in The Uluru Statement from the Heart of 2017, calling on Australians to enshrine Voice, Treaty, Truth in the Australian Constitution."

This is now the law of the land and will apply to 11 million workers including casuals.

Graeme Kelly spoke on behalf of the motion.

3.2 Local Government Financial Sustainability – NSW Local Government, Clerical, Administrative, Energy, Airlines and Utilities Branch

The following motion was referred to National Conference by the NSW Local Government, Clerical, Administrative, Energy, Airlines and Utilities Branch to adopt the following motion into union policy.

Resolution:

"The ASU recognises local governments are an important part of our community. They provide the services that we, as citizens, rely heavily on: waste management, roads maintenance, and the provision of local libraries and public swimming pools to name a few.

The ASU recognises the financial sustainability of local governments across Australia continues to be a challenge and has been undermined by Commonwealth funding arrangements that are no longer fit for purpose.

In recent times the COVID-19 pandemic has presented challenges to local government on a scale not seen before and has further exacerbated the sustainability challenges already faced by the sector. The diversity of the sector means that no single solution or approach will address the sustainability challenges faced by many local governments.

National Conference therefore commits to lobbying the federal government to implement the following measures aimed at improving the financial sustainability of local government:

- Australian government Financial Assistance Grants (FAGs) to Local Government should be set to at least 1% of aggregate Commonwealth tax revenue.
- Reform the Local Government financial system to ensure no councils are financially disadvantaged.

- End cost shifting Government must offer funding and grants to keep pace with delivery costs.
- A federally funded trainee and apprenticeship scheme should be launched centred on Local Government.
- The establishment of a Fair Jobs Code to stop the exploitative use of labour hire, lift standards and to protect the rights of all local government workers.
- Amendments to National Disaster Funding should be made to channel additional funding through Local Government and ensure financial assistance is expended in affected local communities and work performed by locally employed council workers.
- Inclusion of Local Government as a permanent member of National Cabinet
- Rate capping should be abandoned as a matter of priority.
- The Regional Employment Development Scheme (the RED scheme) should be reintroduced. This could be provided at a reasonable cost with the Federal Government providing a base pay equivalent to current safety net payments and council's topping up those payments to the rates of pay applicable in that particular workplace having regard to Award, Enterprise, and Salary System rates of pay in the relevant State or Territory.
- Ensure a national Energy Transition Authority is federally funded and established.

Financial sustainability will allow local governments to provide the goods and services they promise, in an efficient and sustainable manner: because no one can afford for councils to fail due to financial difficulties.
